- 4、为保证认证工作的独立性和公正性, 00SAP 承诺不从事认证 方面的咨询工作,不接受来自其它任何方面的压力。不直接或间接地 提供任何影响认证过程和结论可信性、客观性与公正性的咨询或服 务。
- 5、00SAP 检查并确保参与认证活动的人员都没有任何可能影响 认证过程和结论的商业、财务或其它压力。
- 6、不向拟认证的单一组织提供管理体系内审员或标准的培训。 对机构内设各业务部门 3 年内提供过管理体系内部审核服务的客户 组织不提供管理体系认证服务,除非这种内审服务发生在客户组织提 出管理体系认证申请之前已超过3年。
- 7、0QSAP 在认可的认证业务范围内,规定认证要求、进行审核 和作出认证决定。并对批准、保持、扩大、缩小、暂停或撤销认证的 决定负责。

#### I. VALIDITY AND SCOPE 有效性和范围

- 1. These International Certificate Conditions are applicable to all non-Austrian applicants and holders of certificates issued by Quality Austria Certification GmbH (hereinafter referred to as Quality Austria or qualityaustria) in the area of system certification, verification and validation. This area includes, but is not limited to, certification, assessment, auditing, validation, verification, monitoring, evaluation and assessment of organizations, in particular of their management systems, as well as other related audit services on the basis of normative evaluation models/ standards/ regulations. 这些国际证书条件适用于所有非奥地利申请人和 Quality Austria Certification GmbH(以下简称 Quality Austria或 qualityaustria)在系统认证、验证和确认领域颁发的证书持有人。这一领域包括但不限于对机构,特别是其管理系统的认证、评估、审核、验证、核查、监测、评价和评估,以及基于规范性评估模型/标准/法规的其他相关审核服务。
- 2. For applicants domiciled outside of Austria, certification will usually be carried out in cooperation with local qualityaustria partners, who will provide specific certification activities (esp. auditing) in coordination with Quality Austria and provide local support to applicants. The services provided by the qualityaustria partner shall be subject to its general terms and conditions, which shall apply in addition to these International Certificate Conditions of Quality Austria. 对于居住在奥地利以外的申请人,认证通常将与当地的qualityaustria合作伙伴合作进行,他们将与Quality Austria协调提供具体的认证活动(特别是审核),并为申请人提供当地支持。 qualityaustria合作伙伴提供的服务应受其一般条款和条件的约束 , 这些条款和条件应适用于这些Quality Austria量国际证书条件。
- By applying for a qualityaustria certificate, applicants acknowledge the following terms and conditions. 通 过 申 请 qualityaustria证书, 申请人承认以下条款和条件。
- 4. Certificates issued by Quality Austria shall be subject solely to the following terms and conditions and to the relevant standards on which certification is based. Any deviating terms and conditions (e.g. standard terms and conditions, terms and conditions of purchase) of the applicant are expressly excluded. - I1. SECRECY, CONFIDENTIALITY, DATA PROTECTION, CONSENT TO PASS ON ADDRESSESS AND TO RECEIVE ADVERTISING MATERIALS 保密、数据保护、同意传递地址和接收广告材料
- 1. Quality Austria undertakes to comply with applicable data protection laws, in particular the EU General Data Protection Regulation (GDPR), when processing personal data. Any personal data collected by Quality Austria in relation to the certification activities will be stored electronically and processed by Quality Austria as "controller" within the meaning of the GDPR for the purpose of issuing a qualityaustria certificate, for necessary (audit) documentation according to statutory provisions or relevant standards, for accounting purposes as well as for customer relationship management, including submission of offers for other qualityaustria services (e.g. recertifications and addon certifications, relevant training). The legal basis for the

processing is Art 6.1(b) GDPR (performance of a contract, as far as the data subject is party to the contract), Art 6.1(f) GDPR (legitimate interests pursued by Quality Austria and the applicant in the provision of the agreed **quality**austria services to increase the quality) and Art 6.1(c) GDPR (legal obligations of Quality Austria). Quality Austria在处理个人数据时遵守适用的数据保护法律,特别是欧盟通用数据保护条例(GDPR)。

Quality Austria收集的与认证活动相关的任何个人数据将以电子方式存储,并由Quality Austria作为GDPR意义上的"控制者"进行处理,目的是签发Quality Austria证书,根据法定规定或相关标准提供必要的(审计)文件,用于会计目的以及客户关系管理。包括提交其他Quality Austria服务的报价(如重新认证和附加认证,相关培训)。处理的法律依据是GDPR第6.1(b)条(合同的履行,就数据主体是合同的一方而言)、GDPR第6.1(f)条(Quality Austria和申请人在提供商定的Quality Austria服务以提高质量时追求的合法利益)和GDPR第6.1(c)条(Quality Austria 的法律义务)。

Quality Austria will store any personal data as long as may be necessary to achieve the above purposes. Any master data concerning an applicant (including officers authorized to represent the applicant, applicant's contacts) as well as any data concerning order history will be stored until the end of the business relationship and until the end of the warranty, limitation and statutory retention periods. Any audit reports and audit documentation will generally be stored for a period of 12 years, unless normative or statutory regulations provide for a longer retention period. All information made available to Quality Austria by an applicant which is not public domain will be kept confidential. Quality Austria undertakes not to disclose to third parties any confidential information about an applicant which arises from its activities (including, but not limited to, audit reports and other written statements concerning the results of qualityaustria's activities), except with the applicant's written consent, unless Quality Austria is required to disclose such information by law. or unless Quality Austria is obliged to disclose such information due to normative requirements, or unless the disclosure of such information is not absolutely necessary for the fulfilment of the contract. The applicant acknowledges that any information about the applicant which is made available to Quality Austria or the **quality** austria partner or arises from its activities (including, but not limited to, audit reports) will be made available to the accreditation or certification bodies (e.g. Accreditation Austria,

VDA-QMC, IATF, KBA) on request and that any such body may participate in audits on site. The applicant also agrees that the above data will be sent to qualityaustria's affiliated organizations which will use such data for promotional mailings concerning their training, verification and certification services and products. The applicant agrees to receive from Quality Austria affiliated organisations by mail and email advertising materials and information concerning products and services of these organizations. - The applicant acknowledges that Quality Austria is obliged according to the relevant standards (in particular EN ISO/IEC 17021 - 1, IAF MD 28) to provide the public with information on certifications issued. The public information concerns the name/company name and address of the certified organization, certificate number, certified locations, scope and applicable normative documents, status of the issued certification, date of issue and period of validity. The information is made publicly available via the certificate search on the Quality Austria website and in the case of certifications in accordance with IAF MD 28, these are also published in the IAF database . #### III. LIABILITY OF QUALITY AUSTRIA Quality Austria的赔偿责任

1. The applicant acknowledges that auditing only amounts to a check, on a random basis, of the management system on the basis of normative evaluation models/standards/ regulations. Quality Austria will generally not check the conformity of the relevant organization with the law and does not accept any warranty or liability that the audited organization complies with all legal requirements. qualityaustria's liability is based on the following provisions.申请方需承认,审核只是根据规范的评估模式/标准/条例,随机对管理体系进行检查。Quality Austria一般不会检查有关组织是否符合法律,也不接受被审核组织遵守所有法律要求的任何保证或赔偿责任。

#### qualityaustria赔偿责任基于以下规定。

- Quality Austria is liable to the applicant only for any violation of its contractual obligations by intent or recklessly gross negligence, subject to the following provisions. Quality Austria dis- claims any liability for slight and simple gross negligence. 质量奥地利只对申请人的任何违反其合同义务的意图或不顾后果的重大过失负责,。但须遵守下列规定。Quality Austria对轻微和简单的重大过失不负任何责任。
- 3. Any liability of Quality Austria is limited to typically foreseeable damage incurred by the applicant and shall be limited in amount to the contractually agreed remuneration paid to Quality Austria or the qualityaustria partner for the underly- ing certification services. Quality Austria 的任何赔偿责任仅限于申请方通常可预见的损害,不应超过为基础认证服务支付给Quality Austria 或 qualityaustria合作伙伴的报酬金额。
- Quality Austria disclaims any liability for lost profit, any consequential damage caused by defect, any direct or indirect damage and any pure pecuniary loss .Quality Austria对利润损失、缺陷造成的任何间接损害、任何直接或间接损害以及任何纯粹的金钱损失不承担任何赔偿责任。
- 5. - To the extent permitted by law and unless expressly otherwise agreed with Quality Austria in writing, the applicant guaran-

tees that **quality**austria's services will only be used for the applicant's purposes and not for third parties. If services provided by Quality Austria are passed on to or used for third parties, Quality Austria shall not be liable to that third party.在法律允许的范围内,除非与Quality Austria有明确的书面协议,申请方保证 qualityaustria的服务只用于申请方,而不用于第三方。如果Quality Austria提供的服务被转给或用于第三方,Quality Austria不对该第三方负责。

- 7. If Quality Austria is liable to a third party by way of exception, the provisions of this Section III, including, but not limited to, all limitations of liability included therein, shall be applicable not only between Quality Austria and the applicant but also to that third party. The maximum liability sum agreed in paragraph 3 above shall be applicable in aggregate only once to all injured parties, even if several parties (the applicant a third party or more third parties) have incurred a loss. - 9. #### IV, RIGHTS OF THE APPLICANT 申请人的权利

- Quality Austria undertakes to disclose the individuals carrying out an assignment to the applicant. If the applicant rejects these individuals for substantiated reasons, Quality Austria will endeavor to make a new proposal. The applicant may not object to the members of an audit team if audits are announced on short notice. Quality Austria may select the individuals car- rying out an assignment at its own free discretion, unless na- tional and international regulations, e.g. IAF/EA policies, re- quirements of the accreditation body or laws/regulations, e.g. the EMAS Regulation, provide otherwise . Quality Austria承诺向申请人披露执行任务的个人。 如果 申请人以确凿的理由拒绝这些人, Quality Austria将努力提出新的建 议。如果审核是在短时间内宣布的, 申请人不得反对审核小组的成员。 除非国家和国际法规(如IAF/EA政策)、认证机构的要求或法律/法规 (如 EMAS法规 ) 另有规定 , 否则 Quality Austria可 以 自行 决 定选择 执行任务的个人。
- 2. If an individual assigned by Quality Austria is not able to perform his or her duties immediately before or during provision of a service, e.g. due to illness, he or she will be replaced by another individual in agreement with the applicant or another appointment will be agreed. 如果Quality Austria指派的人员在提供服务之前或期间不能立即履行其职责,例如因病,则将由与客户达成协议的其他人员替代,或另行约定。
- 3. The applicant acknowledges and agrees that observers of the accreditation bodies and/or Quality Austria (e.g. witness auditors or trainee auditors) may participate in on-site services. 申请人承认并同意,认证机构和/或Quality Austria的观察员(如见证审核员或实习审核员)可以参与现场服务。

#### V. OBLIGATIONS OF THE APPLICANT 申请人的义务

1. The applicant shall ensure that any document, data, and other RE\_0 2\_0 4\_0 1 - 1 e\_ GTC\_ System Certification\_ Partner International

information necessary for providing the respective **quality** austria services is provided to Quality Austria also without special request and that Quality Austria is informed of all events and circumstances which could be significant for performing the order. 申请人应确保在无特殊要求的情况下, 向Quality Austria提供提供各自质量服务 所需的任何文件、数据和其他信息,并确保 Quality Austria了解对执行订单可能重要的所有事件和情况。

- The applicant will grant access to rooms, facilities and workplaces. 申请人将准许进入房间 、 设施和工作场所。
- 3. The applicant will take adequate organizational precautions to ensure that the responsible employees are present and prepared to provide practical evidence. 申请人将采取充分的组织预防措施,确保负责的员工在场并准备好提供实际证据。
- 4. The applicant will ensure that all employees questioned by Quality Austria provide candid and true information about all internal affairs relevant to assess the respective management system. 申请人 需确保 Quality Austria询问的所有员工提供与评估管理体系相关的所有内部事务的真实信息。

#### v1. INTELLECTUAL PROPERTY RIGHTS 知识产权

All documents which Quality Austria may provide as hard copies or in electronic form, such as self-evaluation forms, template forms or checklists, shall be Quality Austria's intellectual property and may be used only for the purposes intended by Quality Austria. Except with Quality Austria's express written consent, any other use or disclosure shall be prohibited. In the absence of Quality Austria's consent, the documents may neither be reproduced nor made available to third parties.Quality Austria可能以硬拷贝或电子形式提供的所有文件,如自我评估表、模板表或检查表,均为Quality Austria的知识产权,只能用于Quality Austria预期的目的。除非获得Quality Austria的明确书面同意,否则禁止任何其他使用或披露。未经Quality Austria同意,不得复制或向第三方提供文件。

- 2. Except with Quality Austria's consent, no pictures, audio or video recordings may be made of **quality**austria services.未 经 Quality Austria 同意,不得对 qualityaustria服务进行任何图片、音频或视频记录。
- 3. In case of any violation of Section VI, Quality Austria may assert a penalty of € 30,000 for each violation, without prejudice to Quality Austria's right to assert further damages. 如果有任何违反第VI节的行为,Quality Austria可对每项违反行为处以30000 欧元的罚款,同时不影响Quality Austria主张进一步赔偿的权利。

#### VII, SAFEGUARDING QUALITY AUSTRIA'S IMPARTIALITY AND IN-DEPENDENCE 维护 QualityAustria的公正性和独立性

- The applicant ensures that the applicant will refrain from anything that could prejudice the independence of the individuals assigned by Quality Austria and the **quality**austria partner. This applies in particular to offers for consulting activities or employment as well as contracts for that individual's own account. 申请人应确保申请人不会做出任何可能损害 Quality Austria和 **quality**austria合作伙伴指定的个人独立性的事情。这尤其适用于咨询活动或雇佣的报价,以及个人账户的合同。

#### ARTICLE 8 第8条

#### DEFINITION OF INSURED EVENT 保险事件 的定义

- 1. Any insured event is a breach (act or omission), as a result of which the insured could be liable for damages. If a breach could give rise to multiple obligations to pay damages, this shall be deemed to constitute one event of loss. It shall also be considered a single event of loss where several breaches, even if committed by multiple persons, give rise to one uniform loss. 任何保险事件都是违约行为(作为或不作为),因此被保险人可能会承担损害赔偿责任。如果违约行为可能导致多重赔偿义务,则应视为构成一次损失事件。如果多次违约(即使由多人实施)导致一次统一损失,也应视为一次损失事件。
